General notice of Registerable Interests

Disclosable Pecuniary Interest

5.	Any land in the authority's area for which you or the persons referred to above have a licence (alone or jointly with others) to occupy for a month or longer.	NONE
6.	Any tenancy where to your knowledge the landlord is your authority and the tenant is a body in which you or a person referred to above has a beneficial interest.	NONE

The name of any person or body in which you or a person referred to above has a beneficial interest in securities of that body where: a) that body to your knowledge has a place of business or land in the area of your authority; and b) either- i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issue share capital of that body; or ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or a person referred to above has a beneficial interest exceeds one hundredth of the total issue share capital of that class	NONE

Registerable Non-Pecuniary Interests

3. fail to give further notices in order to bring up to date information given in this notice after my re-election or reappointment or fail to declare a disclosable pecuniary interest that I acquire after the date of this notice and have to declare under the provisions of s31(s2) Localism Act 2011.

I also acknowledge that I may be a breach of the Code of Conduct to-

1. omit information that ought to be given in this notice;
2. provide information that is materially false or misleading;
3. fail to provide written notification to the authority's monitoring officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change of circumstances
